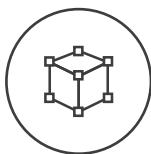
The organization must develop and maintain a design package(s) to demonstrate compliance with design and development requirements. The API Monogram Licensing Program requires the selection of a design package for review during an audit.

## What is Design Package / Design Binders?

- Design: A detailed plan for a product(s).
- Package: A collection of related items to be considered as or acted on together.

The design package therefore is a detailed plan for a product(s) which includes all the background documents, applicable API standards, and the instructions, procedures, specifications, drawings, routers, checklists, process sheets and changes to these documents necessary to produce the product(s) at the manufacturing location.

The API Monogram design package shall include design plans, input elements, output elements, evidence of review/verification and evidence of validation and changes performed on the design if required as per API Spec Q1.
